

# Waiver and Release of Liability

## GREAT WAIKOLOA CANOE RACE \* August 29, 2015

In consideration of being allowed to participate in any way in the Hawaiian Canoe Racing Association and its member organizations athletics/sports programs, and related events and activities, the undersigned:

1. **AGREE** that prior to participating, they each will inspect the facilities and equipment to be used, and if they believe anything is unsafe, they will immediately advise their coach or supervisor of such condition(s) and refuse to participate.
2. **ACKNOWLEDGE** and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. **ASSUME** all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. **RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE** WCC, Inc. d/b/a Waikoloa Canoe Club, Moku O Hawaii Canoe Racing Association, Hawaiian Canoe Racing Association, Waikoloa Land Co., Lava Lave Beach Club, Waikoloa Development Co., AtPac (Hawaii) LP, Kolea Condominiums, Hilton Waikoloa Village, Lanpar/HTL, Lonomakua Partners, LLC, Transcontinental Development (Hawaii) Co., Waikoloa Beach Association, Waikoloa Beach Marriott, Waikoloa Land & Cattle Co., and Waikoloa Resort Association, it's member associations, it's affiliated clubs, their respective administrators, directors, agents, coaches, and other volunteers or employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
